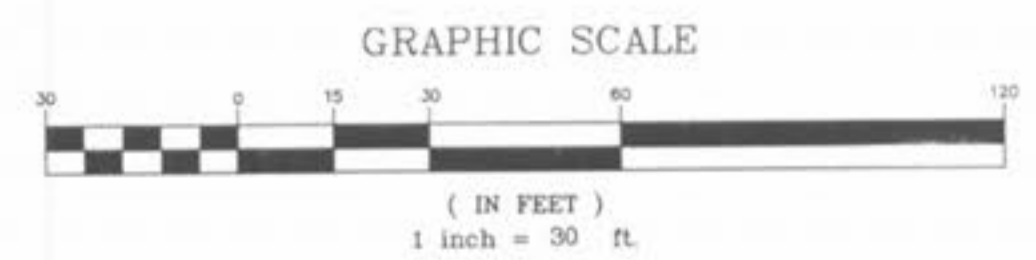


NOTE:
