**FEISE SUBSTATION SITE PLAN**

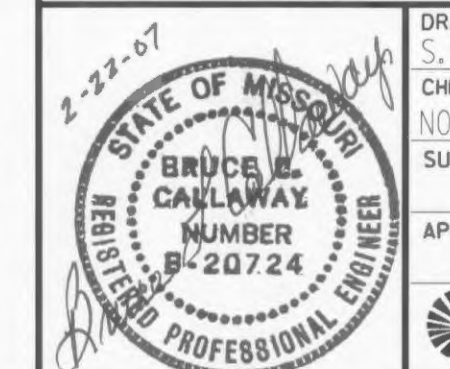
