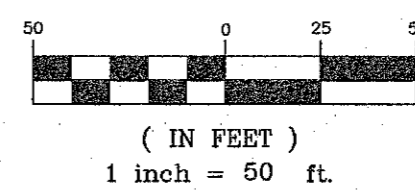


NOTES:
 1. PROVIDE COMPACTED GRANULAR FILL TO ALL WATER MAIN TRENCHES THAT CROSS THE PAVEMENT, LIE WITHIN TEN (10) FEET OF THE EDGE OF PAVEMENT AND/OR THE 1:1 SHEAR PLANE OF THE PAVEMENT.
 2. ALL WATER MAINS ARE TO HAVE A MINIMUM 42" OF COVER.

GRAPHIC SCALE



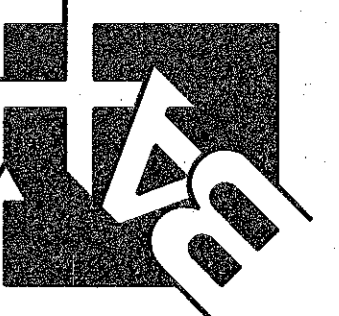

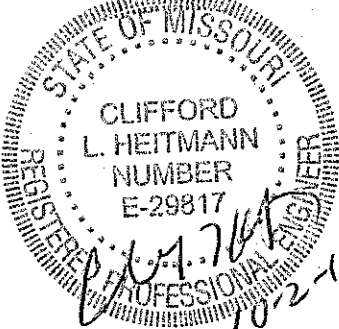

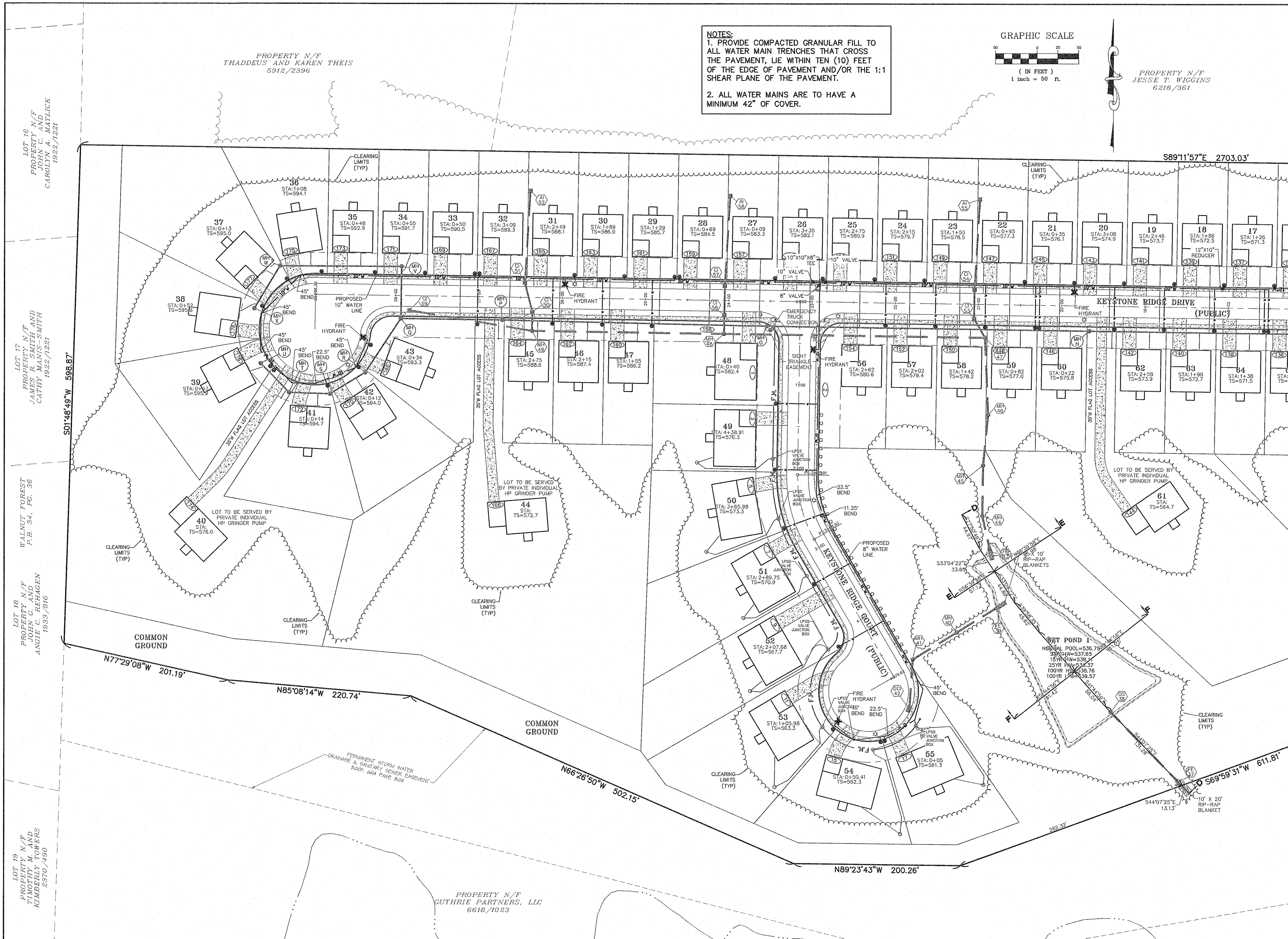
