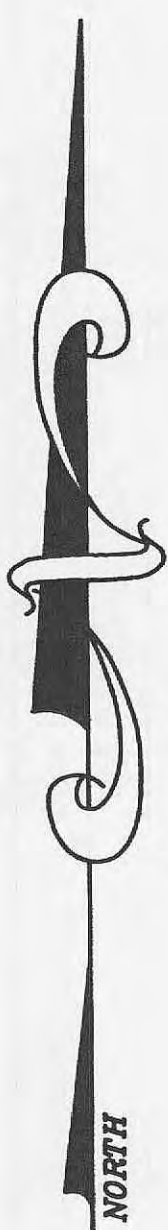
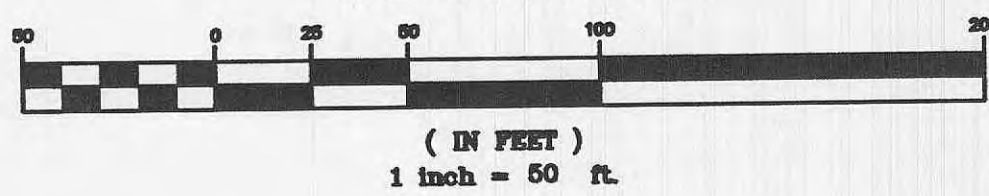


A (TO NORTHEAST - HOFF RD. DITCH)	(1.03Ac)(1.87)	= 1.93 c.f.s.

E (TO NORTHWEST)	(0.56Ac)(1.87)	= 1.05 c.f.s.

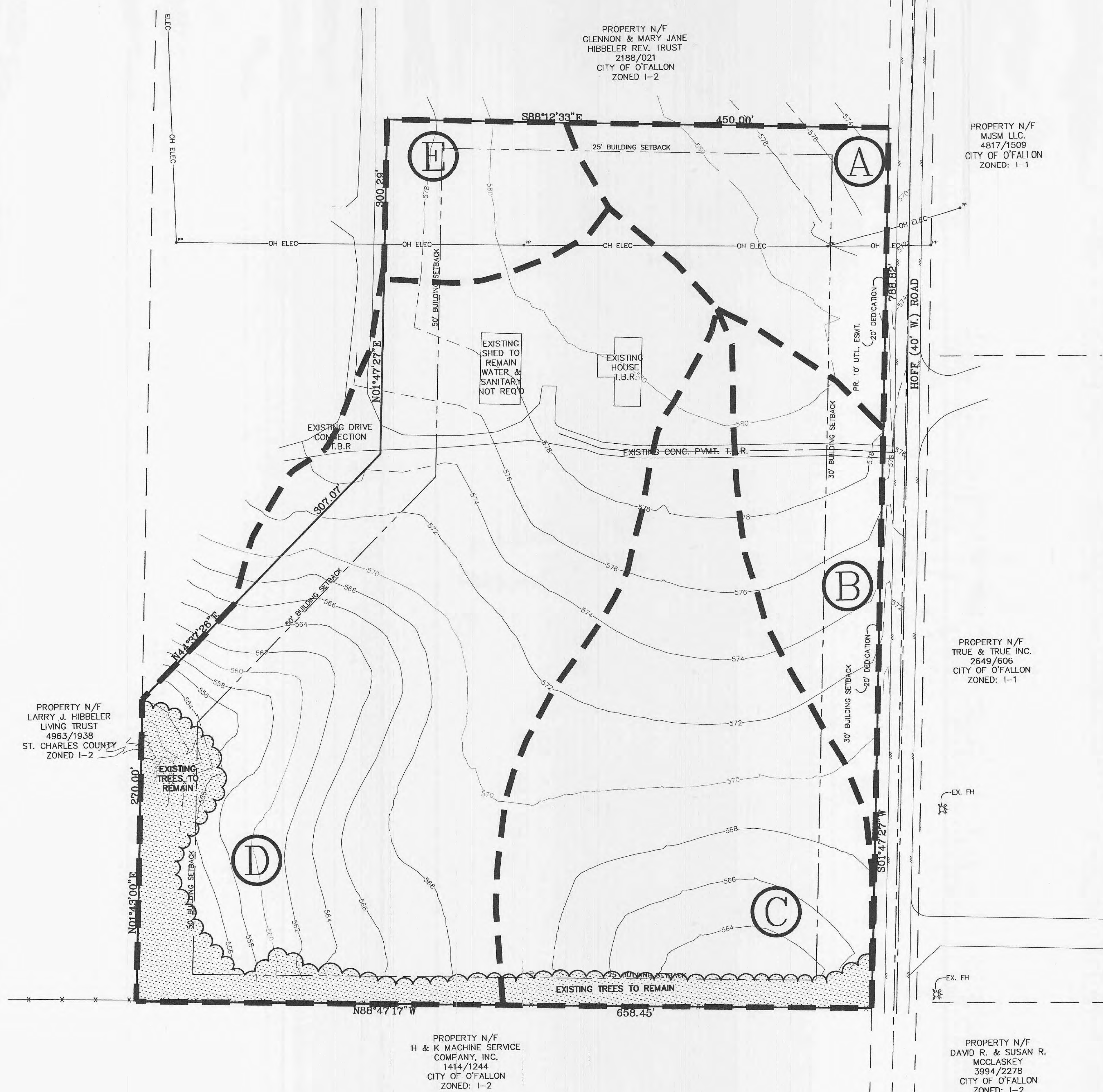


GRAPHIC SCALE
