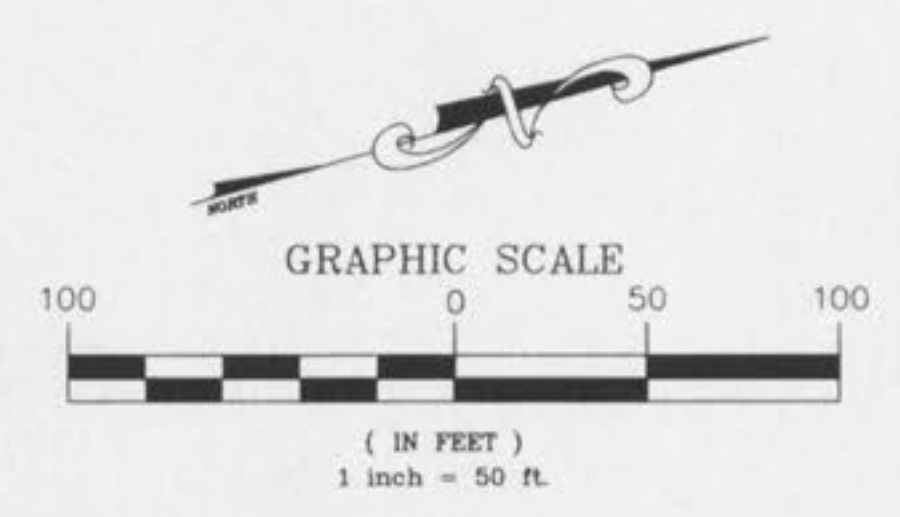
LONG TIMBER DRIVE

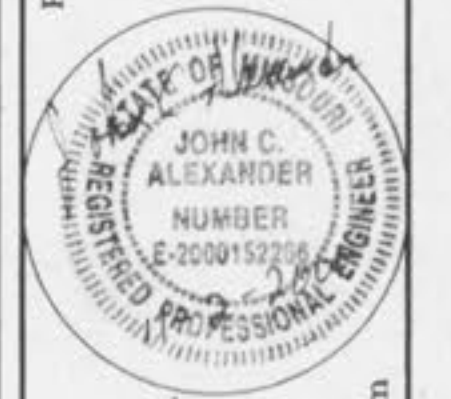
