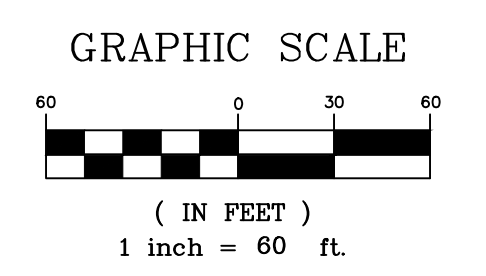


- DUCKETT CREEK ABANDONMENT NOTES:**
1. DUCKETT CREEK SANITARY DISTRICT (DCSD) INSPECTION, COORDINATION AND APPROVAL IS REQUIRED FOR REALIGNMENT AND ABANDONMENT OF EXISTING SANITARY SEWER MAIN.
  2. EXISTING SANITARY SEWER SERVICE SHALL NOT BE INTERRUPTED.
  3. EXISTING SANITARY SEWER MAIN SHALL NOT BE ABANDONED UNTIL REPLACEMENT SANITARY SEWER MAIN IS INSTALLED, INSPECTED, TESTED AND APPROVED BY DCSD FIELD INSPECTORS.
  4. RECORDED EASEMENTATION IS REQUIRED FOR REPLACEMENT SEWER PRIOR TO ABANDONMENT OF EXISTING SANITARY SEWER.
  5. EXISTING SANITARY SEWER MAIN TO BE ABANDONED SHALL BE GROUT FILLED AND PLUGGED AT EACH TERMINUS OF ABANDONED PIPE.
  6. EXISTING SANITARY MANHOLES TO BE ABANDONED SHALL BE REMOVED.

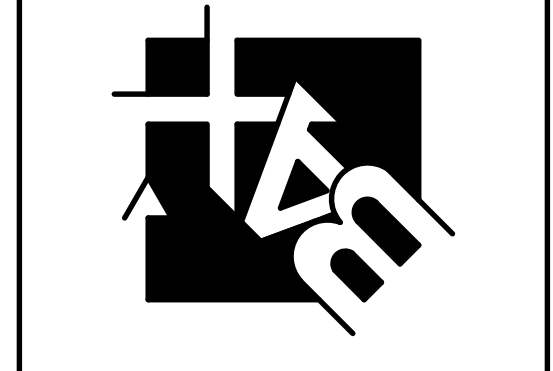
- P.W.S.D. NO.2 NOTES:**
