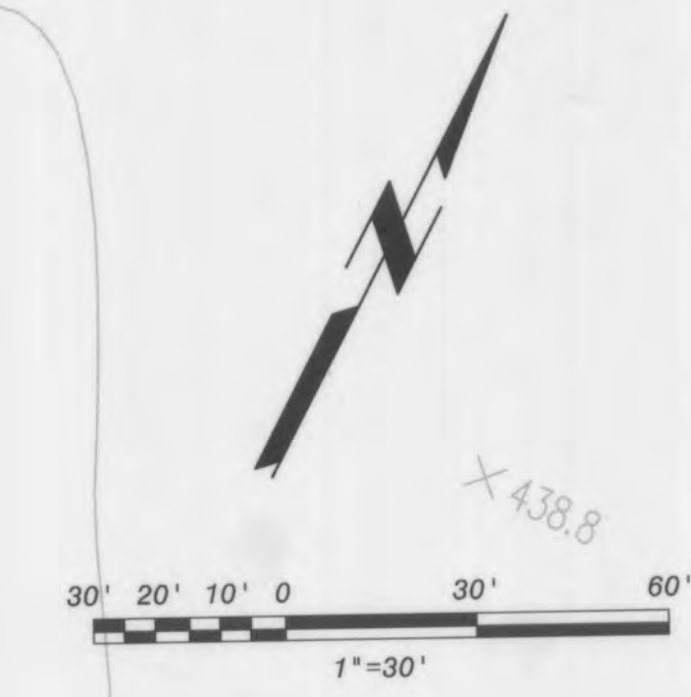
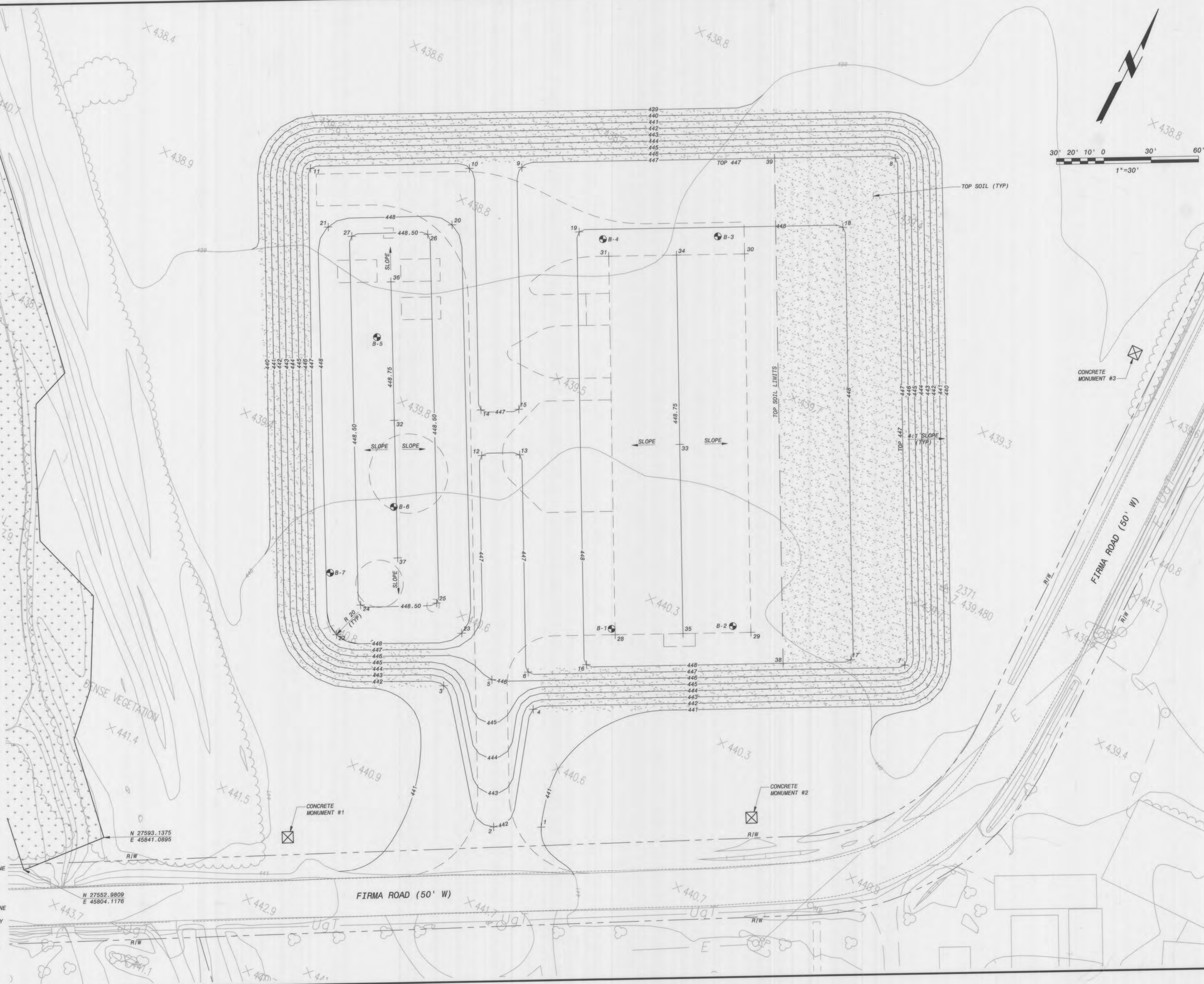
CONCRETE MONUMENT #2
