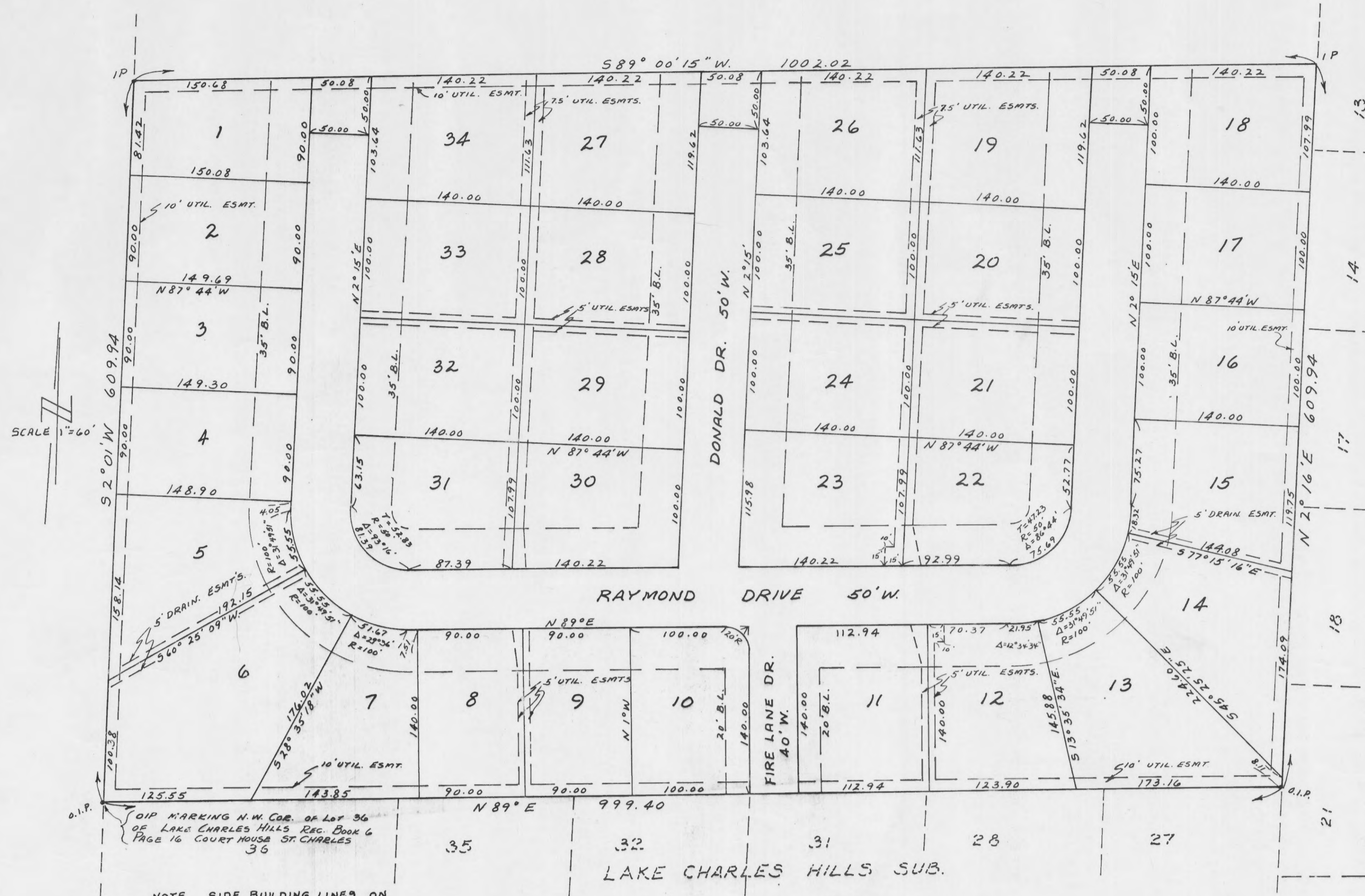


LAKE CHARLES HILLS NO. 3.

This is to certify that at the request of Charles W. and Lillian L. Williams, Husband and Wife, I have surveyed and subdivided a tract of land located within Section No. 13, Township 47 North, Range 2 East of the Principal Meridian, St. Charles County, Missouri, which subdivided tract is more particularly described as follows:

Commencing at an old iron pipe marking the Northwest corner of Lot 36 of Lake Charles Hills, a subdivision recorded in Book 6 on Page 16 in the Office of the County Recorder, Courthouse, St. Charles, Missouri; thence from said beginning point N 89° E. 999.40 Ft. to an old iron pipe marking the Northeast corner of Lot 27 of Lake Charles Hills Subdivision; thence N. 2° 16' E. 609.94 Ft. to an iron pipe; thence S. 89° 0' 15" W. 1,002.02 Ft. to an iron pipe; thence S. 2° 01' W. 609.94 Ft. to the point of the beginning, containing 14 acres, and that the results of this survey and subdivision are correctly represented upon this plat.
