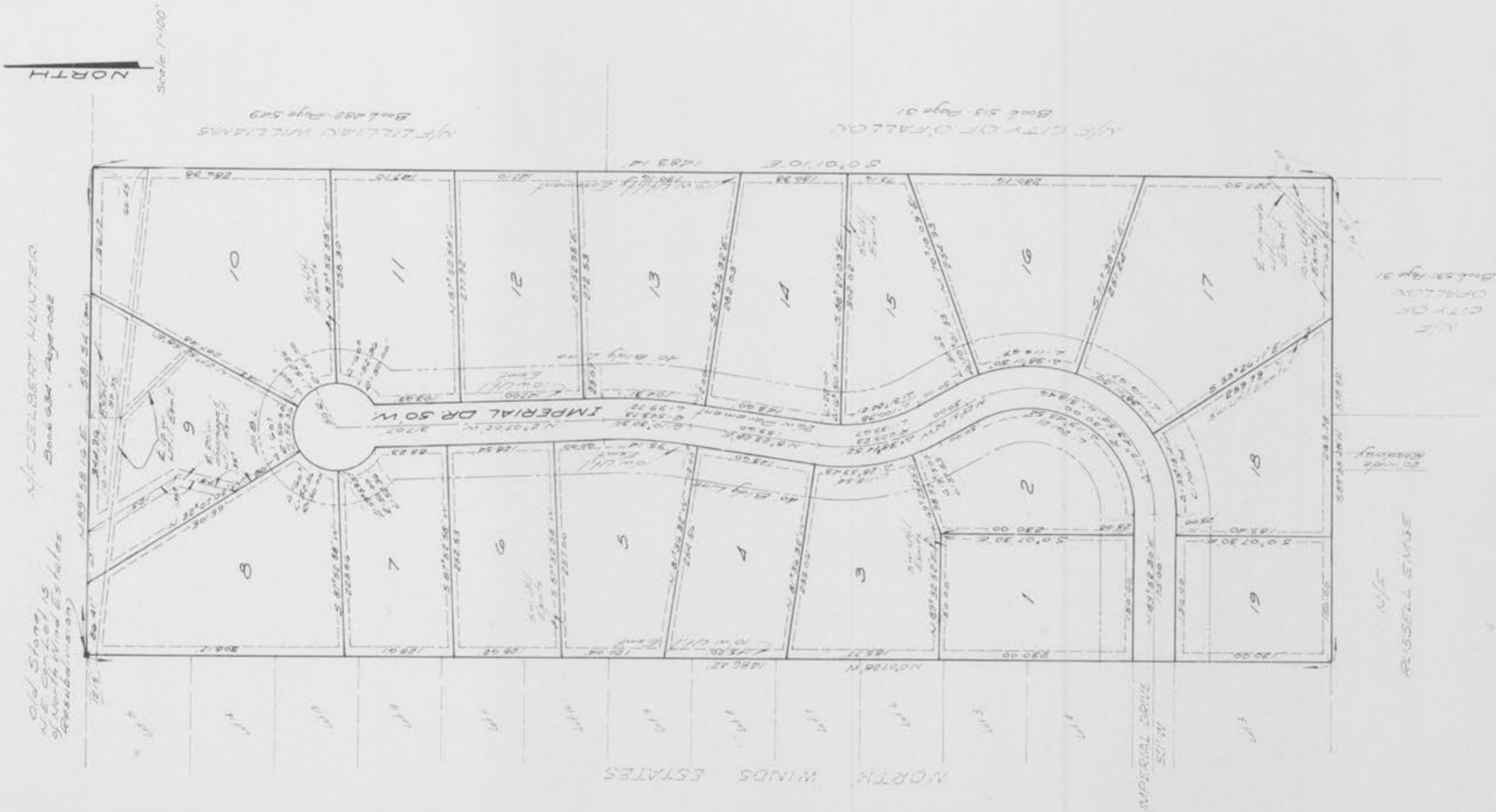


# NORTH WOODS ESTATES
